#### How much of my time will I need to give?

It is anticipated that the survey will take approximately 15-20 minutes to complete.

#### What benefits will I, and/or the broader community, receive for participating?

The information gathered from the survey regarding the impact of poor oral health among women in perimenopause/menopause will help in addressing the oral health needs of women in perimenopause/menopause. Developing an understanding of the barriers women face may help in developing supportive strategies to improve oral health. Beyond this, there will be no immediate benefit to the broader community.

Participation is entirely voluntary, and you are not obliged to be involved. If you do participate you can withdraw at any time without giving reason. Therefore, data collected from you prior to withdrawal may not be able to be deleted and may be used for the purpose of this project.
